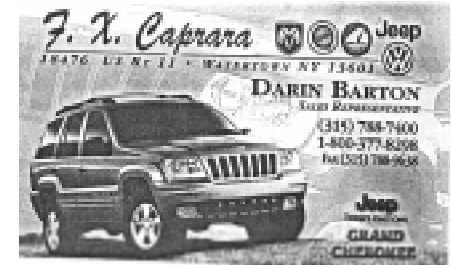
Our ATV trailer, donated by F.X. Caprara, will be here Aug. 3rd.
